A) Objectives of the MOU

- i. Cooperation and promotion of education and training in areas of mutual interest.
- ii. Any other appropriate academic support and interaction agreed between authorized representatives of Arya Mahila Post Graduate College, Lahurabir Rd, Hathua Market, Lahurabir, Chetganj, Varanasi, Uttar Pradesh & Dr. D.Y. Patil Institute of Management studies, Akurdi, Pune.

B) Broad areas of Collaboration

1. To provide academic interaction, by facilitating training for teachers and students at Dr. D.Y. Patil institute of Management Studies, Adurdi, Pune on relevant topics.
- i. To organize workshops/ seminars/ conferences and Personality Development Programmes at Arya Mahila Post Graduate College, Lahurabir Rd, Hathua Market, Lahurabir, Chetganj, Varanasi, Uttar Pradesh.
- ii. To provide necessary support for research and training at Arya Mahila Post Graduate College, Lahurabir Rd, Hathua Market, Lahurabir, Chetganj, Varanasi, Uttar Pradesh Use of academic infrastructure by bonafide students & bonafide faculty of both the institutions i.e. Arya Mahila Post Graduate College,, Lahurabir Rd, Hathua Market, Lahurabir, Chetganj, Varanasi, Uttar Pradesh & Dr. D.Y. Patil Institute of Management Studies, Akurdi, Pune.

- iii. To encourage participation of teachers and students in Workshops, Conferences, Sports & Cultural Activities conducted by both the institutions.

2 - Terms & Conditions

- i. Expenses shall be mutually decided agreed upon one month in advance during the finalization of the implementation of the academic activities. Expenditure on activities will be borne by the Institution hosting the same.
- ii. The bonafide faculty members and bonafide students of Arya Mahila Post Graduate College, Lahurabir Rd, Hathua Market, Lahurabir, Chetganj, Varanasi, Uttar Pradesh & Dr. D.Y. Patil Institute of Management Studies, Akurdi, Pune can avail the library facilities.
- iii. The MOU may be amended, renewed and terminated by mutual agreement of the institutions at any time.
- iv. Either institute shall have the right to terminate this MOU by 60 days prior written notice to the other institute.
- v. Academic activities conducted should be mutually beneficial to both the institutions.

3 Confidentiality

- i. Arya Mahila Post Graduate College, Lahurabir Rd, Hathua Market, Lahurabir, Chetganj, Varanasi, Uttar Pradesh & Dr. D.Y. Patil Institute of Management Studies, Akurdi, Pune, agree to hold in confidence all information/data obtained from either institute or created during the performance of MOU, and will not disclose the same to any third party.
- ii. The above confidential clause under this MOU excludes the information/data possessed by either institute before entering into this MOU or independently developed information already available through public domain.

E) Duration of MOU

- i. This MOU, unless extended by mutual written consent of the institutes, shall expire on two years after the effective date specified in the opening paragraph, however on review the MOU shall be extended for another two years by mutual consent.

F) Coordinators

Both institutions will designate faculty as coordinators for implementation of this agreement.

G) Intellectual Property Rights

The Intellectual Property Rights (IPR) that arises as a result of joint research and collaboration activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of both the institutes.

This MOU is extended in duplicate with each copy being an official version and having equal legal validity. By signing below the institutes, acting by their duly authorized officers have caused this Memorandum of Understanding to be executed, effective as of the day and year first written above.
