1. That the partner of this Memorandum of Understanding are Arya Mahila P.G. College, Varanasi, represented by Dr. Rachana Dubey,





8. That when written notice has been served to the other party for termination of Memorandum, in that case it will be considered terminated three months after the receipt of such notice.




9. That each partner will bear its own financial liability and other party will be immune from such financial liability.
